#### SHAREHOLDERS WILL BE ASKED TO CONSIDER AND VOTE ON THE FOLLOWING MATTERS:

**ELECTION OF DIRECTORS:** Information respecting the election of directors may be found in the "Election of Directors" section of the Management Information Circular.

**APPOINTMENT OF AUDITORS:** Shareholders will be asked to appoint McGovern Hurley LLP as the Corporation's auditors for the ensuing year and to authorize the directors to fix their remuneration.
